#### What is the purpose of this update?

This document tells you how the ARK Disruptive Innovation Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. #### Description of this fund

The fund aims to outperform the benchmark of an absolute return of 10% per annum over a rolling five-year period before fees, expenses and taxes. The fund provides access to a global share portfolio that offers thematic exposure to disruptive innovation across a number of sectors, and geographies.


Noah made the first investment of \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Noah received a return after fund charges were deducted of \$1369.79 (that is 13.69% of his initial \$10,000). Noah paid \$12.50 other charges. This gives Noah a total return after tax of \$1265.55 for the period ending 31 March 2021.
